FINAL TERMS

The Notes will be consolidated and become fungible and form a single Series with the existing EUR 1,500,000,000 Series No. 1624 due 11 January 2033 issued on 11 January 2023, EUR 50,000,000 Series No. 1665 due 11 January 2033 issued on 16 May 2023, EUR 50,000,000 Series No. 1668 due 11 January 2033 issued on 31 May 2023, EUR 50,000,000 Series No. 1670 due 11 January 2033 issued on 22 June 2023, EUR 250,000,000 Series No. 1712 due 11 January 2033 issued on 3 April 2024 and EUR 25,000,000 Series No. 1723 due 11 January 2033 issued on 4 June 2024 (the "**Original Notes**").

The date of these Final Terms is 31 May 2024.

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Notes in any member state of the European Economic Area (each, a "**Member State**") will be made pursuant to an exemption under the Prospectus Regulation from the requirement to publish a prospectus for offers of the Notes. Accordingly any person making or intending to make an offer in that Member State of the Notes may only do so in circumstances in which no obligation arises for the Issuer or any Dealer to publish a prospectus pursuant to Article 1 of the Prospectus Regulation or supplement a prospectus pursuant to Article 23 of the Prospectus Regulation, in each case, in relation to such offer. Neither the Issuer nor any Dealer has authorised, nor do they authorise, the making of any offer of Notes in any other circumstances.

The expression "**Prospectus Regulation**" means Regulation (EU) 2017/1129, as amended.

This document constitutes the Final Terms of the Notes described herein for the purposes of Article 8 of the Prospectus Regulation and must be read in conjunction with the Base Prospectus in order to obtain all the relevant information, save in respect of the 2022 Terms and Conditions incorporated by reference therein. Full information on the Issuer and the Notes described herein is only available on the basis of a combination of these Final Terms and the Base Prospectus.
